

APPENDIX: DETAILS OF THE OPEN CALL FOR 42 WATERLOO STREET

NAC is looking for partners who share the vision of Singapore having a sustained, mature and vibrant theatre scene. We believe that such a scene requires a pipeline of quality writing by emerging and established playwrights, who will be given a sustained level of support to enable the development of a playwright and his writing.

It is with all these in mind that NAC is calling for proposals to establish a centre for the development of text-based works for Singapore theatre, with the aim to nurture and develop our creative talents to dream the next canonical Singapore production. We envisioned this centre, to be based at 42 Waterloo Street, as the engine room* for Singapore theatre.

(Nicholas Hytner, Director of the UK's National Theatre has described The Studio as the engine room for the National Theatre)*

APPLICANTS ELIGIBILITY

NAC welcomes proposals from Singapore-based individual arts practitioners, collectives comprising individual arts practitioners and arts-related groups/organisations. Interested parties should possess a track record of at least 5 years of professional involvement with the performing arts scene in Singapore, and you are encouraged to consider the broad spectrum of partners you could work with to realise the full potential of 42 Waterloo Street.

If you are an individual applicant, you must be a Singapore Citizen or Permanent Resident.

For collectives and arts-related groups/organisations, applicants need not be a Singapore-registered company or a society at the time of application, but should you be successful, you must be prepared to register accordingly. At the point of application, collectives must have at least 50% of its members who are Singapore Citizens or Permanent Residents.

APPLICATION SUBMISSION

Interested Applicants are required to complete Form A (either Form A-1 or A-2 on the NAC website) and provide the following submissions:

(I) For An Individual or A Collective made up of Individuals:

- a) Form A-1
- b) Profile of yourself or Collective: A Curriculum Vitae (CV) and achievements for the past 5 years
- c) Additional for Collectives: Vision statement of the collective and organisational structure, and the profile of each member of the Collective
- d) Detailed proposal for 42 Waterloo Street

(II) For An Organisation:

- a) Form A-2 Profile of the Company and organisational structure
- b) Vision statement and achievements for the past 5 years
- c) Detailed proposal for 42 Waterloo Street

Scope and Format of Proposal

The detailed proposal should include the following:

1. Proposed developmental and programming approach, and how the programmes will optimise the facilities of 42 Waterloo Street. Participants should indicate how they intend to use the spaces and also the frequency of use.
2. Operating model including financial projections detailing expenditure and potential revenue for the next 3 years, and project timelines to reflect key milestones.
3. Other supporting documents (where relevant).

The application submission (including all the necessary documents) should be sent via email to **nac_fd@nac.gov.sg** by **10 June 2013 (23:59 hr)**. NAC will not be able to accord any extension beyond this deadline. Only timely and complete submissions will be considered.
