

## Declaration

By submitting this application, I, the primary applicant, hereby represent and warrant that I am duly authorised by the organisation to, and do hereby, submit this application for and on behalf of the organisation, and agree and confirm that:

- Without prejudice and in addition to any rights of NAC or United Overseas Bank Limited (“UOB”) to disclose and/or use information relating to the organisation whether at law or otherwise, the organisation agrees and consents to NAC and UOB and their respective officers, employees, representatives and agents using and disclosing any information which the organisation provides NAC or UOB as required by, pursuant to, or in connection with this application and/or the programme, to any persons (including but not limited to (in the case of UOB) any of UOB’s branches, representative offices, affiliated, associated or related corporations and their respective staff and agents, whether in Singapore or elsewhere (collectively, “UOB Group Members”), for the purposes of application assessment, programme planning, administration and management of the programme, research, data analysis, marketing, promotion or publicity for NAC or UOB, and/or any other purpose NAC or UOB deems appropriate, necessary or desirable in connection with this application and/or programme (“Permitted Purposes”).

(a) If the organisation (through its representatives or otherwise) provides NAC or UOB with personal data of any individual as required by, pursuant to, or in connection with this application and/or the programme, the organisation represents and warrants to NAC and UOB that it (i) has notified the relevant individual of the purposes for which data will be collected, processed, used or disclosed; and (ii) has obtained such individual’s consent for, and hereby consents on behalf of such individual to, the collection, processing, use and disclosure of his/her personal data (including, without limitation, photographs, video and audio recordings of such individual taken during the programme) by NAC and UOB, in each case, in accordance with or for the Permitted Purposes or for the purposes of conducting surveys or communication on any events, products or services that the organisation or its representatives have requested information on or which NAC or UOB thinks may be of interest to the organisation or its representatives, and confirms that it is authorised by such individual to provide such consent on his/her behalf. In order to carry out the purposes listed, UOB may share such personal data with the UOB Group Members.

(b) The organisation agrees and undertakes to notify NAC and UOB promptly upon its becoming aware of the withdrawal by the relevant individual of his/her consent to the collection, processing, use and/or disclosure by NAC or UOB of any personal data provided by the organisation to NAC and/or UOB. As a result of such withdrawal, the organisation may no longer be able to be considered for, or participate in, the programme.

(c) Any consent given pursuant to this application and/or the programme in relation to personal data shall, subject to all applicable laws and regulations, survive death, incapacity, bankruptcy or insolvency of any such individual and the termination or expiration of the programme.
